For the year ended December 31, 2020, the company estimates that it will incur (all numbers approximate) a loss from operations of \$7.3 million, compared to an \$11.9 loss from operations during 2019. The \$4.5 million decrease in loss from operations was due primarily to a \$4 million decrease in general and administrative expenses and a \$600,000 increase in gross profit, with no significant change in revenue. Because the company's financial statements have not yet been finalized, these amounts are subject to change.
